MUNICIPALITY(S): York SITE DESCRIPTION:


This site includes Wiggly Bridge, Fisherman's Walk, and York Harbor from the Seabury Road bridge to the mouth of the York River. The Harbor is adjacent to the local hospital, so transit routes in this area are especially critical. The Harbor is an important resource for recreational boaters/fisherman and also a working waterfront serving lobstermen and fishermen in the area. The Wiggly Bridge and Fisherman's Walk are important cultural and recreational resources in the Town.

VULNERABILITIES & EXPOSURE TO HAZARDS:


Wiggly Bridge, Fisherman's Walk, and multiple roads are exposed to flooding. Area could support future marsh migration to a limited degree around the islands off of Lilac Lane and Harris Island Road. The land between these two roads is conserved, but in general conserved lands are scarce in this area.

At risk infrastructure and habitat:

 Tidal Waterfowl Wading Bird Habitat; Rare Threatened Endangered or Exemplary Habitats and Natural Communities; Undeveloped Habitat Blocks and Connectors; Current Tidal Marshes; Riparian Habitat and Connectors; Future Coastal Habitats; Conserved Lands; Freshwater Wetlands and Vernal Pools; Seabird Nesting and Shorebird Areas; Submerged Aquatic Vegetation and Shellfish Growing Areas; Fin Fish Habitats.



Roads and other resources in the York Harbor area are exposed to flooding, particularly by the Town Docks.
